### PROFESSIONAL PROFILE

Steven Hill is an experienced policy director, author and researcher based in San Francisco, with over two decades of experience in mission-oriented policy formation. Mr. Hill has a long history of directorships in the policy institute/think tank world. He is a former program director and senior fellow at New America, a policy institute based in Washington DC. In Winter 2018 he was journalist-in-residence at the Berlin Social Science Center (WZB), and in Winter-Spring 2016 was the recipient of the Berlin Prize and the Holtzbrinck Fellowship at the American Academy in Berlin. Prior to that Mr. Hill was director of the Political Reform Program at the New America Foundation, and assistant director and senior fellow at FairVote/Center for Voting and Democracy, a nonprofit organization that he co-founded in 1992.

Mr. Hill has played a crucial leadership role in advancing some of the most important new policy ideas and proposals of our times, several of which have been adopted by governments and endorsed by national leaders. He was a pioneer for the adoption of ranked choice voting, which has now been adopted by [20 US cities, including New York City, and the state of Maine](#). In his policy management, books, opeds/articles and media interviews, Mr. Hill has been an early leader of the national efforts to enact universal voter registration, national popular vote for president, public financing of campaigns, lowering the voter registration age to 16/17, term limits for US Supreme Court justices, reforms of the US Senate, and more. Shifting his focus to the Digital Economy in recent years, his proposal for a “portable safety net” for US workers was touted by President Barack Obama in his [2016 State of the Union address](#), by US Senator Mark Warner (who has held hearings on federal legislation) and by [forty leading business, government, labor and NGO leaders](#) who called for a portable safety net as a [foundation for the 21<sup>st</sup> century economy](#); four states have introduced legislation for a portable safety net. Mr. Hill’s proposals for digital licenses, a data oversight agency, consumer tech “best practices” and public interest AI have garnered major media coverage in the US and Europe.

Mr. Hill is a leading commentator and analyst in the United States and Europe on the digital economy, the future of work, data privacy, digital licenses, artificial intelligence, startup platforms, political economy, transatlantic relations, electoral systems, democratic methods, political reform and future trends. He is a prolific writer of articles, op-eds and blog posts, with his work appearing in the *New York Times*, *Washington Post*, *Wired*, *Financial Times*, *The Atlantic*, *Fast Company*, *Los Angeles Times*, *Boston Globe*, *San Francisco Chronicle*, *Politico*, *Business Insider*, *Forbes*, *Salon*, *Guardian*, *Die Zeit*, *Le Monde*, *Süddeutsche Zeitung*, *Tagesspiegel*, *Handelsblatt*, *Frankfurter Allgemeine Zeitung*, *Mother Jones*, *Project Syndicate*, *New York Daily News*, *The Nation*, *Washington Monthly*, *American Prospect*, *China-US Focus*,

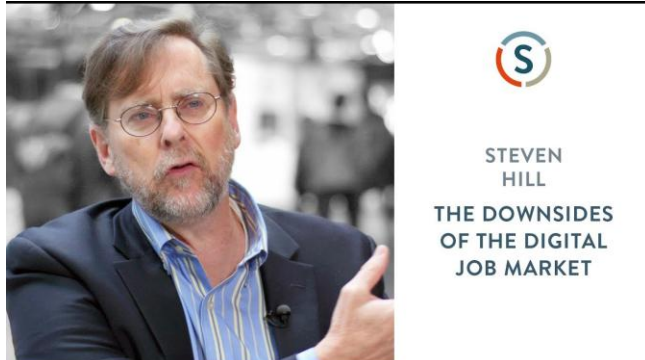
